After spending the day depicting an ongoing living history reinactment from the American Revolution time period in honor of Conrad and Peter Apgar, members of The Light Company join members of the Apgar Family Association celebrate their eleventh annual reunion which was held on September 21, 1985 at the Cokesbury United Methodist Church, Cokesbury.

The President's Message:

As your new President, I first want to send my sincere greetings! For those of you unable to attend our twelfth family reunion in Cokesbury this past September, I took over as fourth President of the Apgar Family Association since our reunions started up a second time in 1975.

And even though it is early February as you read this, I hope you had the merriest of all Christmas' and the happiest and healthiest of all New Year's 1987!

After our elections this past September, I also agreed to continue to serve as Newsletter Editor Wearing these two hats, I would like to



address a few of the concerns we face as a family organization come 1987 and beyond.

You may first wonder why I kept a December 1986 date on this issue when it first hit our mails in February of 1987? As you know from our September reunion invitation I had originally planned to publish this issue in November of 1986. But faced with moving to my new home, illness in my immediate family, unexpected busy period at work, and getting caught up in that stretch of time from Thanksgiving through Christmas to New Year's, the days just were not long enough.

With 1986 past, this will be the last time we will charge for our family newsletter. This past September we incorporated for the first time as an organization and early in 1987 you should have received your membership application. As mentioned in these invitations, the annual newsletter will become part of the membership fee.

Also in 1987 we will be looking for new faces to help serve on various reunion committees. Our reunions need a fresh change and currently the eleven family members who have worked so hard these past twelve years need a rest. Besides, eleven people a reunion does not make and with attendance to our September reunions in the 180-240 range, we can always use new faces and ideas.

One of my biggest challenges as your new President is keeping both our reunions together and interest high so they continue. Sad as it may be, by the year 2000 there will no longer be a typical American family. Instead we will have many different types of families with the traditional family - married couple with children - continuing to shrink from almost half of all family types in 1970 to a quarter by the year 2000 - and that is only thirteen years from now!

The President's Message - Continued:

The last few decades has seen the American household go through rapid changes. We have gone from households headed by a husband and wife with children to many types of households now headed by single parents, single people, unmarried couples and others.

And with our family having a long and proud history here in America since 1734, it is ever so important for us as a family to preserve our history in writings and for all of us to continue to hold a successful and rewarding annual family reunion. I am confident we will accomplish both goals plus much more as we head into the year 1987.

In closing, I continue to welcome articles for future editions of this newsletter, thank those of you who have contributed to this issue of our newsletter, encourage you to support our Volume II publications of our family history, and ask if you are willing to help serve on a committee for our 1987 family reunion to be held once again in Cokesbury this September 19th, please contact either myself or any of the other newly elected trustees listed below.

Saturday, September 20, 1986, Cokesbury United Methodist Church, Cokesbury, New Jersey


Henry Apgar, Vice-President, opened the twelfth annual meeting, extending a hearty welcome to the family members and friends from himself and Wilson Jones, President.

Then Henry spoke of the progress that has been made in the past year in the following areas of public relations, fifty copies of Volume I reprint, the work that has begun on the printing of our next Volume II under the direction of Dorothy Apgar, our family historian and the work done by Robert H. Apgar, attorney for our family association. Robert filed papers for Certificate of Incorporation and prepared a set of By-Laws of the Apgar Family Association, Inc., reflecting the intention of the By-Law Committee. These documents were received and officially accepted on this day during an earlier meeting of the trustees of our Association.

Continuing with his speech, Henry urged family members to view the outstanding exhibit at the Hunterdon County Library. Titled "The Apgars-A County Family History Since 1734", this exhibit was on display for the month of September at the library.


Robert H. Apgar, Attorney, was then introduced and he explained the reasons for the Incorporation and By-Laws. Robert O. Apgar presented the slate of nominees for trustees, which was approved and accepted: Helen Apgar, Califon, NJ, Reba Bloom, Clinton, NJ, and Al Tiger, Somerville, NJ all have one year terms; Barbara and Richard Apgar, Glen Gardner, NJ, and Henry and Ruth Apgar, South Plainfield, NJ all have two year terms; and Robert O. and Dorothy Apgar, Flemington, NJ, George M. Apgar Jr., Chester, NJ, and George N. Apgar, Jr., Middlesex, NJ all have three year terms as members of the newly created trustee title.

The Minutes - Continued:

Henry then turned the meeting over to Wilson Jones, President, who greeted the reunioners and presented awards to: youngest child present - Gretchen, ten months, daughter of Gary and Susan Apgar of Lebanon Township, NJ; the oldest female in attendance - Lenola Layden, age 93 of Whitehouse, NJ; and the oldest male present - Hugh Browne, age 89 of Whiting, NJ; the longest married couple - John and Dorothy Apgar, 60 years, of Milburn, NJ; Marybelle Hoffman of Wheat Ridge, Colorado, who traveled the farthest to attend our reunion; and the largest immediate family present was Helen Hartrum of Plainfield, NJ with thirteen members present!

Barbara Apgar, treasurer, reported \$578.58 in the working ac-count with \$236.65 of that coming from the successful paper weight project. In the Apgar book account the total monies of that account is \$402.02.


George N. Apgar, Jr., Corresponding Secretary for the past seven years gave his final report as family secretary. He answered approximately 222 letters since the last reunion and 350 invitations were mailed for this September reunion. States represented at this year's reunion were New York, Pennsylvania, North Carolina, Ohio, Illinois, Wisconsin, Virginia, Florida, Georgia, Kentucky, and Colorado. George thanked John Apgar of Flemington for taking the photograph of the family at this year's reunion. The Hunterdon Democrat and the Courier-News gave good news coverage on Association activities. Newsletter number eight will be published in November and George reported articles are needed for this issue. 194 paperweights were sold at \$10.00 each and from this project, a check for \$236.65 was given by George to Barbara for the working account.

The Minutes - Continued:

Family Historian, Dorothy Apgar, reported that fifty copies of Volume I were reprinted and sold with inserts for additions and corrections included. Additional copies of Volume I may be ordered by contacting her. Volume II will be divided into four parts and the same size as Volume I will result in this volume. Each copy of Volume II will cost \$40.00 plus NJ residents state sales tax of 6% which includes mailing. Dorothy concluded by asking that any additions and/or corrections for Volume I and future Volume II's be sent to her.

Recording Secretary, Reba Bloom, read the minutes of the 1985 annual reunion meeting. Then Robert O. Apgar presented the slate of officers for 1986-1987: President George N. Apgar, Jr., Middlesex, NJ; First Vice-President Henry Apgar, South Plainfield, NJ; Second Vice-President Imelda Mercier of Bricktown, NJ; Treasurer George M. Apgar, Jr., of Chester, NJ; Recording Secretary Al Tiger, Somerville, NJ; Corresponding Secretary Robert O. Apgar, Flemington, NJ; and Historian Dorothy Apgar, Flemington.





While attending our 11th reunion from Inwood, West Virginia, David David and Virginia Povlick donated a family Bible of Frederick Apgar (Jacob line 6.12.9) to our Association!

It was during the ceremony honoring Peter A. and Conrad Apgar that Pastor Gerry Schiermeyer of the Cokesbury United Methodist Church offered a memorial prayer in their memory.

The Minutes - Continued:

In closing, Wilson Jones reminded all that the next reunion will be held on Saturday, September 19, 1987, Cokesbury United Methodist Church, Cokesbury, New Jersey.

The meeting adjourned at approximately 3:00 PM. Following the business meeting, Dorothy Apgar, Historian, spoke about "Our Western Ancestors" and that today some in the western states are starting local Appar Family Reunions. A collection was taken which came to \$214.00 and it was reported that 195 members were present at this year's reunion.

On The Radio And Television:

In 1986, we were very fortunate to have two fine public relations events on our family.

On April 7, 1986, In Celebration 1886-1986, An American Portrait on the CBS-TV Network did a segment on our own Dr. Virginia Apgar! Even though it lasted for only sixty seconds, it was a super tribute to our most famous family member.



Dr. Virginia Apgar was an anesthesiologist who witnessed the delivery of countless babies. observed that infants were not thoroughly examined until well after birth by which time serious disorders could have developed. In 1952 Apgar devised a brief effective examination for babies in their first minute after birth. The Apgar Score system takes only a few seconds but can detect many disorders that require immediate treatment. It is a potential lifesaver for millions of newborns in America and through-out the world. I am Celeste Holm with An American Portrait.

Lasting just under one-half hour on the radio, our own Helen, Rob-ert, and Dorothy Appar were on New York Radio Station WOR this past August 14, 1986. WOR drew a record 4,500 spectators for the day when it broadcast from Flemington and joining the day's activities which also included talk host Joe Franklin, our own Governor Kean, and even Tiny Tim, Helen, Robert, and Dorothy spoke of our early reunions in the mid-1970's, how to start up a family reunion, and even answered questions from the audience that gathered under blue skies and sunshine. Those fortunate to be able to hear the program know how much they enjoyed doing it. Thanks for a job well done!

Membership Chairperson Report:





Illustrated here are some of the sights we enjoyed on this very special occasion!


The Light Company is a group of history enthusiasts who devote their time to reliving our Revolutionary War history.

When asked to perform, members re-construct military evolutions and drill of the military camp life.






The Apgars - A County Family History Since 1734

Proud of our heritage, and hoping to inspire others to trace their roots, members of the Apgar Family Association set up a display at the Hunterdon County Library, Flemington, NJ. Shown throughout the month of September 1986, a highlight of the exhibit was a large, colorful family tree carrying the names of the many Hunterdon families who have married into the Apgar Family over the years. Also included in the exhibit was early church records from the Lebanon Reformed Church dating back two and one-half centuries. Taylor-Wharton steel mill memorabilia, Revolutionary War and Civil War data, and other family records the family has collected over the years from their Show-and-Tell Tables set up by family members during their annual family reunions in Hunterdon County, NJ.

I was very fortunate to be in attendance at an Alexandria Township Historical Society meeting that was held on April 23, 1986 in the former Mt. Salem Methodist Church building. The Frederick line was more fortunate because Reba Bloom of this line spoke to members of the society on the Apgar Family and son number nine - Frederick, who along with his wife, Elizabeth, are buried in the Mt. Pleasant Cemetery, Mt. Pleasant, New Jersey (1832 and 1848 death dates respectively).

Reba's talk started with 1734, the year our patriarch arrived in the American Colonies and ended with the family of Frederick and Elizabeth Mettler Apgar and their 12 children.

Philhower Family Annual Reunion:

The 70th Annual Reunion of the Philhower Family in the Hunterdon County area was held on Saturday, September 6, 1986 at the local Cokesbury United Methodist Church, Cokesbury, New Jersey.

Preparations were made for over one hundred members and guests to attend. A turkey dinner was served by the women of the church around 1:00 PM and registration and children's games started earlier in the day at around 10:30 AM.

After dinner a short business meeting was held followed by a slide program presented by the Hunterdon County Park System on "A Visit To The Hunterdon County Park System".

A large bulletin board, prepared by Mrs. Raymond Philhower of Morristown, was available for all to enjoy. It had some very interesting items covering happenings of all family members since their last yearly reunion.

The Philhower family are descendants of Philip Philhower, who came from Germany by way of Holland and arrived in Philadelphia in 1748. Shortly thereafter he settled in Mountainville in Hunterdon County. In Volume I of the Apgar Family History, approximately sixty Philhower Family members are listed with many more promised to be recorded in Volume II.

The first reunion was held on August 25, 1917 in the Hickory Grove of George Lindabury in Farmersville, Hunterdon County. Today many members are now living in various states throughout the country.

Clover Family Exchange:

Somewhere around 1767 to 1770 Catherine Clover married Peter Apgar a/k/a Peter of Lebanon. This information is found in T. F. Chamber's EARLY GERMANS OF NEW JERSEY, published 1895, page 239; Peter Apgar of Lebanon, son of John, md (1) Catherine Clover.

According to a publication entitled "First Four Generations of Peter Apgar of Lebanon, son of Johannes Peter Apgard" researched by Helen M. Apgar of Ithaca, NY and Helen S. Apgar of Califon, NJ, Catherine Clover was the daughter of Peter Clover of Prussia and Catherine Sharpenstine of Holland.

Thirteen children were born to this couple and this book gives their names, birth dates, and the names of spouses and marriage information when it applies.

This information helps to verify (1) that Catherine Clover Apgar was, indeed, the mother of the thirteen children (another source suggests she was a second wife and may not have been the mother of any of them; (2) that Catherine's mother's maiden name was Sharpenstine. "The Vandenbark History" (by Isa Reed) has sup-ported this, and our October research in SLC indicates that there were a number of Sharpe families in the German Valley area of New Jersey in Hunterdon and Somerset Counties whose names had been shortened from Sharpenstine.

If you find anymore descendants of Clover and Sharpenstine in your family research, I would appreciate hearing from you. We still have a lot of work to do on those early lines and sure can use some help. Thank you.
